NUTS2 VALUES

CLARIFICATION

As is well known, values for both mineral and organic soils are available for 14 out of 37 NUTS2 areas in Germany, which differ significantly. We had repeatedly pointed out the problem of verifying the applicable NUTS2 value in each case and presented possible solutions.

There are apparently rumours circulating in the market about flat rates (e.g. 5%) for the proportion of biomass from organic land in NUTS2 areas that have already been accepted by SURE. We hereby clarify that this **is NOT** the case.

SURE DATABASE

UPDATE OF LEGAL REPRESENTATIVES
